




Project 1: Conservation Based Reporting Tools and Rate Structure Implementation

UPDATES

- ► Grant Agreement with DWR has a termination date of December 31, 2019.
- ► There is an estimated savings of \$261,000 that cannot be expended by the deadline.
- SAWPA met with DWR staff on November 5, 2019 and they agreed to a one-year extension.

CONCLUSIONS

- Per DWR feedback, funding cannot be moved between Project 1 and 2;
- Will move some cost savings between categories in Project 1 to cover items such as imagery costs for Upper Santa Margarita Watershed and rates implementation costs;
- Recommend awarding grant cost savings to the project leads in the Santa Ana River Watershed (the SAWPA member agencies and MWDOC) on a first come, first serve basis.
 - For example, IEUA has approximately \$44,000 in costs that can be billed to DWR going forward that would expeditiously spend down much of the cost savings and ensure retention was released to the member agencies as quickly as possible.

RECOMMENDATION

- Receive and file this update on the Drought Grant Agreement; and
- 2. Approval of distribution of grant cost savings associated with the High Visibility Turf Removal and Retrofit rebates on a first come, first serve basis.

Program Development and Task List

- ♦ Smartscape is a partnership between SAWPA member agencies and OC Coastkeeper, developed in 2015 during SARCCUP initial grant application effort;
- ♦ Supports water customers that have transitioned from turf grass to drought tolerant landscaping through specific tasks:
 - ♦ Landscape site visits
 - ♦ Develop written training materials
 - Workshops, training, etc.
- Makes physical improvements to irrigation systems (prevents leaks and overwatering)







- Joint Powers Authority focused on regional planning;
- Member agencies include city and county governments;
- In 2018 they launched the Aerial Imagery
 Consortium to gather imagery the same year as the census, 2020.


