Call to Order/Introductions

The Basin Monitoring Program Task Force (Task Force) meeting commenced at 1:05 p.m. at the Santa Ana Watershed Project Authority (SAWPA) located at 11615 Sterling Avenue, Riverside, California.

Approval of October 30, 2018 Meeting Summary

Meeting summary was approved with changes.

I-15 Express Lanes Project Dewatering – TDS Offset Request – Griffin Dewatering/Skanska

The Riverside County Transportation Commission and its project partners, Griffin Dewatering Corporation and Skanska Construction Company, are adding two express lanes to the I-15 in both directions. Part of this project involves dewatering, which results in a discharge into the Santa Ana River Reach 3. The volume of water anticipated will range from 4.0 MGD to 6.9 MGD for a period of four to six months. At the request of Regional Board, Teresa Jakeway, Skanska Construction Company representative, provided a PowerPoint presentation on the dewatering details and options for the I-15 dewatering project. A discussion of the possible TDS impacts to the Santa Ana River ensued.

Mark Norton added that in the past, the Task Force has accepted funding support from de minimis projects to mitigate the impacts of their discharges. The financial contributions were applied to the Wasteload Allocation Model in order to run models and scenarios. Regional Board will reflect on Task Force discussion and meet with OCWD staff to make an evaluation on whether additional model runs or work is needed to allow a De Minimum Permit for the I-15 dewatering project to discharge to the river.

Wasteload Allocation for Future General TDS De Minimis Permits – Risk Science

The Task Force is running into more and more projects that may have salt discharge impacts and seek general TDS de minimis permits. At the last Task force meeting, the possibility of having a ghost allocation in the Santa Ana River Wasteload Allocation Model (WLAM) for when these projects come up was discussed. The issue with this approach is that the locations of future projects are unpredictable. It was the consensus of the Task Force that future projects seeking general TDS de minimis permits would likely need to run the SAR WLAM to determine salinity impacts instead of having the Task Force set up a separate wasteload allocation for future unknown projects.

SAR Wasteload Allocation Update - Geoscience

Johnson Yeh, Geoscience, provided a PowerPoint presentation with an update on Geoscience's responses to comments on draft Technical Memo No. 3 (TM3). Comments were received by the City of Corona, Elsinore Valley Municipal Water District, Inland Empire Utilities Agency/Chino Basin Watermaster, Orange County Water District, and Risk Sciences. The Task Force requested time to review Geoscience's updated responses to comments.

Geoscience submitted a request for Change Order No. 3 to Task Order No. GEOS374-01 in the amount of \$29,710. Geoscience will revise assumptions for six WLAM scenarios and reruns, conduct additional analyses on the results from the six WLAM scenarios. They will also conduct sensitivity runs to better understand key issues and prepare for and participate in up-to two additional half day monthly meetings to describe project status and/or present draft and results to the Basin Monitoring Program Task Force and/or Regional or State Water Boards. Mark Norton stated that contingency funds are available to pay this effort. Regional Board advised the dischargers to contact them if they need to renew their discharging permits due to upcoming deadlines.

MOVED, to approve Change Order No. 3 to Task Order No. GEOS374-01 for \$29,710 for the SAR WLAM Update.
