#### 5. <u>NEW BUSINESS</u>

# A. ASSESSING HOMELESSNESS IMPACT ON WATER QUALITY, RIPARIAN AND AQUATIC HABITAT IN UPPER SANTA ANA RIVER WATERSHED | TASK 1 REPORT (CM#2020.8)

Mark Norton provided the PowerPoint presentation on Assessing Homelessness Impacts on Water Quality, Riparian and Aquatic Habitat in (the) Upper Santa Ana River Watershed contained in the agenda packet on pages 11-27. This work is funded by the Proposition 1 IRWM Disadvantaged Communities Involvement (DCI) Program.

On February 5, 2019, a \$74,441 contract was awarded to GEI Consultants; this update provided a report on the completion of Task 1 – Literature Review and Assessment of Existing Information. Key elements of Task 1 include: (a) assessing the current nature and extent of stream and waterbody-adjacent homeless encampments in the upper watershed (above Prado Dam); and (b) providing the best available information about the relationships between the presence of homeless encampments and impacts to water quality and riparian and aquatic habitats. Task 2 is the development of a preliminary monitoring program, aligned with existing monitoring efforts in the upper watershed. Norton emphasized currently there is no funding source to undertake a monitoring program. Committee Member Harrison encouraged staff to work in a coordinated effort with other involved agencies before we move toward a program that is not funded. Norton assured that the consultant is in fact working with other agencies and not duplicating efforts. However, we are under no obligation to move forward with a monitoring program.

This item was for informational and discussion purposes; no action was taken on Agenda Item No. 5.A.

#### B. PURCHASE OF AN EMERGENCY GENERATOR (CM#2020.9)

It was the consensus of the Commission that they would move the item based on the materials contained in the agenda packet; there was no presentation or discussion of Agenda Item No. 5.B. Staff was encouraged to contact WMWD staff regarding a tagging program they have to monitor movable equipment.

**MOVED,** authorize the transfer of \$48,000 from Building Reserves to the General Fund and authorize the General Manager to issue a Purchase Order to YC Power Systems in the amount of \$63,243.56 for the purchase of a Generac Model MDG75DF4 portable diesel powered generator and a GTS automatic transfer switch.
