## **DRAFT 2019 RIVERWALK ATLAS**

SAWPA staff is finalizing the QA/QC process of the draft 2019 Riverwalk Atlas. There were discussions regarding the improvement of breaking points, whether the thresholds were descriptive enough, and possibly overlaying population data to the Atlas.

## PLANNING FOR THE 2020 RIVERWALK

Riverwalk volunteers have been assigned to their Riverwalk groups according to their agency. Groups 12 and 13, areas by Hamner Avenue below Van Buren were not as critical so it was decided not to survey. Due to COVID-19, the Riverwalk will not be promoted to volunteers from the public. We continue to accept Conservation Team agency volunteer staff members. Equipment pick logistics are still being worked on; SAWPA will distribute information as soon as possible.

#### UPDATE ON THE TEAM'S VAN BUREN BRIDGE HABITAT PROJECT

Ian Achimore provided the PowerPoint presentation posted to the Conservation Team webpage updating the Team on the Van Buren's Bridge Habitation Project. Achimore noted the Project's Lessons Learned. Discussion ensued on how to possibly add on to the existing groin and add new groin on the other side of the riverbank.

  - Possibly funding the Police Department in their efforts to patrol Holiday and weekend off road vehicle trespassing.

- Possibly have new Assistant Field Supervisor at Palms Springs Fish and Wildlife office, Rollie White, share his experiences with Sucker fish projects from other regions.
