Call to Order/Introductions

The Basin Monitoring Program Task Force (Task Force) meeting commenced at 1:32 p.m. in a virtual Zoom Meeting, in response to, and in compliance with, COVID-19 regulations. Brief introductions were made.

Approval of December 13, 2021 Meeting Notes

The December 13, 2021 meeting notes were approved as posted.

Workshop 2 – Critical Analysis of SAR SNMP Ambient Water Quality and Alternative Methods to Comply Pt. 2: Consideration of Alternative Methods – West Yost

Veva Weamer provided a PowerPoint presentation titled Basin Planning Priorities Task 1 Workshop – Surface Water Monitoring Requirements and Goals for the Santa Ana River Watershed, Pt. 1: Consideration of Alternative Methods. She explained an overview of the process that West Yost will take in evaluating the current surface water monitoring program and how it's conducted. The approach focuses on figuring out what questions need to be answered by the monitoring program and how the data is analyzed to satisfy different surface water objectives. For each Reach, the surface water objectives, metrics for compliance, data used to maintain compliance, and methods of analyzing the metrics will be thoroughly evaluated to determine an improved set of planning priorities. Today's meeting focused on information provided for Reaches 2 and 3 in detail, with Reaches 4 and 5 being a focus at a future meeting.

For each Reach, the following were presented to the Task Force for discussion:

- various sampling points
- compliance requirements (current surface water objectives) and rationale from the Basin Plan Amendment (BPA)
- historical references for methods used
- historical data and variances in calculated concentrations, as well as potential causes for variances
- potential methods for calculating data
