## Draft Basin Monitoring Program Task Force FY 2022-2023 Budget - SAWPA

Mark Norton presented a draft FY 22-23 BMP budget for the next fiscal year as it approaches. This version of the 2022-2023 Fiscal Year Budget for the Task Force was initially reviewed last year during the budget review for Fiscal Year 2021- 2022. Due to additional funding needs for planning priorities, it was approved by the Task Force to defer the annual contributions for the Triennial Ambient Water Quality update to be collected during Fiscal Year 2022-2023 to alleviate some of the financial burden off of Fiscal Year 2021-2022. The draft budget document will be distributed to the Task Force after the meeting for review. There was no action taken on the budget today and will be brought back for approval from the Task Force at the next meeting.

#### Draft Basin Plan Amendment Update – KSC/Regional Board Staff

Tess Dunham, of Kahn, Soares, and Conway, LLP, requested an update from Cindy Li, of the Regional Water Quality Control Board (RWQCB), on the Basin Plan Amendment (BPA), approved by the RWQCB at their December 2021 meeting. Cindy Li stated that the BPA and the administrative record has a tentative presentation date of May 15, 2022 for State Board approval.
