Call to Order/Introductions

The Basin Monitoring Program Task Force (Task Force) meeting commenced at 9:32 a.m. in a virtual Zoom Meeting, in response to, and in compliance with, COVID-19 regulations. Brief introductions were made.

Approval of August 30, 2022 Meeting Notes

The August 30, 2022 meeting notes were approved as posted.

Integrated Report and SAR TDS Listings Response - Regional Board/Tess

Tess Dunham, of KSC, provided a verbal update on the draft justification for a Category 4B. The draft justification is hoped to be sent over to the Regional Board sometime later last week. Comments and feedback will be requested from Task Force stakeholders once feedback from the Regional Board is obtained.

Update on Recommended Surface Water Monitoring Plan – West Yost

Veva Weamer, of West Yost, provided a PowerPoint presentation titled Update on Recommended Surface Water Monitoring Plan. Ms. Weamer reviewed the recommendations for Reach 3 (filtered Total Nitrogen requirement for TIN Objective), Reach 2 (Use of 5-year average of SARWM volume-weighted method vs. 60-month volume-weighted method), and Reach 2 & 3 (ability to upload calculated TDS from EC measurements to CEDEN). The Draft Report of the 2022 Santa Ana River Quality Work Plan is planned for review in October 2022. Once ready for review, the report will be distributed to the stakeholders for a 21-day review period for comments.

Groundwater Monitoring Plan and Ambient Water Quality Update - West Yost

Samantha Adams, of West Yost, provided a PowerPoint presentation titled *GW (Groundwater) Monitoring Program Data Gaps*. Ms. Adams reviewed recommendations for the Groundwater Monitoring Network, including various Groundwater Management Zone (GMZ) raster maps to discuss data gaps and data quality. Data gaps were presented and described to the Task Force stakeholders to understand the factors that contributed to determining data gaps.

A proposed process for filling data gaps was also reviewed in the presentation, listing responsible agencies and stakeholders that would be responsible for relaying that data to SAWPA. During the Task Force meeting, a draft list of responsible agencies was provided for discussion and feedback to West Yost. The updated list/document was placed on the Task Force website for reference. Next steps on the development of the monitoring plan include:

- Receiving feedback on the process to identify and fill data gaps,
- assigning the responsible agencies,
- documenting the monitoring program and data gaps,
- circulating and presenting the proposed scope for 2021 ambient water quality and circulating the draft groundwater monitoring program report.

Any questions/feedback on the proposed groundwater monitoring program can be provided to Samantha Adams of West Yost. The proposed scope for the 2021 Ambient Water Quality and the Draft Groundwater Monitoring Program Report are set to be circulated and then presented to the Task Force around the time of the September 2022 meeting.
