
Santa Ana River Watershed Weather Modification Pilot Program Press Kit











About the Santa Ana River Watershed Weather Modification Pilot Program

The Santa Ana Watershed Project Authority (SAWPA) is currently implementing a four-year Weather Modification Pilot Program in the Santa Ana River watershed. The program includes cloud seeding, which means introducing silver iodide into clouds. This process stimulates the formation of ice crystals and ultimately leads to increased precipitation. The primary goal of this program is to gather important data that will help enhance the local water supply and improve the resilience of the Santa Ana River watershed. The program started on November 15, 2023, and will run until April 15, 2027.

Cloud Seeding Methods

The Pilot Program uses two ground-based seeding methods, called Cloud Nuclei Generators (CNGs) and Automated High Output Ground Seeding (AHOGS).

Seeding Locations

The Pilot Program strategically selected 15 suitable locations for the generators to maximize their effectiveness in reaching desired clouds.
