1. Call to Order & Introductions

The MSAR TMDL Task Force Meeting was called to order at 9:31 a.m. by Rick Whetsel at SAWPA with all participants participating remotely.

2. Approval of Meeting Notes from the November 20, 2023 MSAR Task Force Meeting

The November 20, 2023 meeting notes were approved as posted.

Regional Water Quality Monitoring Meeting Items:

1. Update: 2023-24 Santa Ana River Regional Bacteria Monitoring (Rebecca Dunavant/CDM Smith) Becky Dunavant, CDM Smith provided a presentation to update on the status of the 2023-24 Santa Ana River Regional Bacteria Monitoring. This included a brief overview of the sampling program, an overview of dry weather compliance for each priority group, and general trends in the water quality data.

Next steps include the monitoring of a single storm event (as a requirement of the MSAR TMDLs) between now and March and preparation of the draft annual report due in April 2024.

2. RWQM Task Force Administration (SAWPA Staff)

Rick Whetsel presented to the Task force on the selection of a consulting firm to implement the Santa Ana Regional Bacteria monitoring program. This included a brief review of the RWQM Task Force, the SAR Regional Bacteria Monitoring program and the process to select a consultant to oversee and implement the Santa Ana River Regional Bacteria Monitoring Program.

The recommendation of the Proposal Technical Review Committee was to select GEI Consultants, based upon the results of the proposal evaluations and scoring, as the recommended consultant with the top proposal rating reflecting the consultant's experience, knowledge of the program, technical expertise, and working relationship with the Task Force.

Following brief discussion by stakeholders a motion was put forward by Rebekah Guill representing RCFC&WCD and seconded by Michael Mori representing County of Orange to approve the recommendation of the Proposal Technical Review Committee.

MOVED to approve recommendation of the Proposal Technical Review Committee to authorize SAWPA staff to execute an agreement with GEI Consultants to oversee and to implement the Santa Ana River Regional Bacteria Monitoring Program.

MSAR TMDL Meeting Items:

1. Update: Limited MSAR Basin Plan Amendment (Tess Dunham /KSC and Richard Meyerhoff & Steven Wolosoff/GEI)

Tess Dunham provided an update on the limited Basin Plan amendment informing the Task force that they are working to address comments received. She stated that the consultant team has been meeting with Regional Board staff to discuss the schedule, timeline for compliance, justifications for the wetweather compliance schedule, and the schedule for Regional Board to consider the updated TMDLs and are waiting on final comments from staff.

At this time, Tess and GEI are working to get this item on the Regional Board calendar before the end of the calendar year.

Moving forward, the plan is to provide that schedule at our next meeting, noting the new requirements under AB 2108, which require additional community outreach.

Richard Meyerhoff added that the consultant team was requested by Regional Board staff to provide them brief presentation on why we were recommending to extend the wet weather compliance period an additional twenty year compliance schedule. Regional Board staff is currently reviewing and we expect comments fairly soon.

2. Status Update: Bacteria Reduction Implementation Activities

a) RCFC&WCD

Rohini Mustafa reported to the Task Force that the District and City of Riverside are continuing their work on the conceptual design phase of their investigation of the Magnolia Center Storm Drain, which historically has experienced high bacteria counts in its dry weather flows.

The project is intended to help improve water quality by diverting the Magnolia Center Storm Drain to the City's Regional Water Quality Control Plant.

b) SBCFCD

Chris Bland reported to the Task Force that the District has completed their CBRP sampling activities for 2023, and will restart CBRP sampling activities in July 2024.
