- Task 1 Draft CEQA Scoping and Tribal Outreach Document
 - Status: Completed (Scoping meeting held on January 9, 2023)
- Task 2 Draft Outline of Basin Plan Amendment (BPA) Supporting Technical Report
 - Status: Task Completed (Fall 2022)
- Task 3 Draft BPA with Supporting Technical Report
 - Status: Ongoing...
 - July 2023 Draft Technical Report submitted to Task Force for review
 - September 2023 Received comments on Draft Technical Report
 - October/November 2023 Discussion with Regional Board staff/Task Force regarding request for additional justification for proposed 20-year extension of Wet Winter Condition TMDLs
 - January 2024 Additional justification ("White Paper") for 20-year extension submitted to Regional Board staff
 - May 31, 2024 Regional Board staff provided comments on 20-year justification; also provided additional comments on Draft Technical Report
 - July 16, 2024 Meeting with Regional Board staff to discuss comments

STATUS OF EXISTING PROJECT TASKS

 - Status: Not started; awaiting completion of Task 3
- Task 5 Draft Substitute Environmental Document (SED)
 - Status: Internal drafted prepared based on July 2023 Technical Report; some revision proposed project required based on May 2024 comments on Draft Technical Paper and White Paper
- Task 6 Draft BPA Resolution
 - Status: Not started yet; work is to be completed by Tess Dunham and Regional Board staff
- Task 7 Assistance Assembling Administrative Record & As Requested Support to BPA Adoption Process
 - Status: Completed in part; documents referenced in Technical Report have been compiled during document development
- Task 8 Project Coordination (participation in Task Force meetings)
 - Status: Attended Task Force meetings since project initiation in September 2022; additional meetings with Regional Board staff to discuss need for White Paper; comments on submittals

 - Revise existing internal draft SED based on revisions to the Technical Report and provide Draft SED for Task Force Review;

 - Prepare and submit Final Revised Technical Report.
