Amendment #3 to the LE&CL TMDL Task Force Agreement is scheduled to expire on June 30, 2025.

LESJWA staff, in their role as Task Force Administrator, recommends that stakeholders consider an amendment (Amendment #4) to extend the current 2012 Task Force Agreement by two years, until June 30, 2027. This extension can be executed through an Administrative Action by the Task Force Administrator, as outlined in the language of Amendment #3.

Recommendation: Approve Amendment #4 to extend the LE&CL TMDL Task Force Agreement for a period of two years to June 30, 2027.
 - b. **Action Item:** Approve second year option to extend Aquatechnex Agreement for Services for Canyon Lake Alum Dosing.

February 2022 LESJWA approved a three year agreement for services with Aquatechnex to conduct up to two (2) semi-annual Canyon Lake alum dosings. This agreement included two 1-year options to extend the agreement (four additional application events).

August, 2024, the Task force executed the first 1-year option to extend the agreement.

Recommendation: Direct LESJWA staff to exercise the second 1-year option to extend the Agreement for Services with Aquatechnex to provide semi-annual Canyon Lake alum dosings to support the Lake Elsinore and Canyon Lake TMDL Task force for CY 2026.
