Call to Order & Introductions

The Lake Elsinore/Canyon Lake TMDL Task (Task Force) meeting was called to order at 1:30 p.m. by Rick Whetsel, with participants participating remotely.

Approval of Meeting Notes from March 3, 2025 Task Force Meeting

The March 3, 2025 meeting notes were approved as posted.

Status: Regional Board Update (Regional Board)

Lauren Briggs, Regional Board, stated that the Regional Board is scheduled to adopt the revised TMDLs for Lake Elsinore and Canyon Lake at the Santa Ana Water Board meeting on July 25, 2025. She mentioned that adjustments are being made based on received comments, and a limited public comment period will be reopened by May 9th. The July 25th meeting will be held in the City of Orange, with limited comments accepted only on revisions.

Brian Covellone, Regional Board, introduces Regina Adigwe as the new Irrigated Lands and Non-Point Source Program contact, replacing SueAnn Nieal.

Update: TMDL Update Activities (Tess Dunham, KSC and Steve Wolosoff, GEI)

Tess Dunham, KSC, indicated that once the limited revisions are available for review by the Task Force, she will work on a general comment letter in support of the revisions for the TMDL on their behalf. As a result of the February Regional Board public hearing, the City of Banning will be removed as a responsible party with this Basin Plan Amendment, due to their lack of prior involvement. This results in minor updates to summary milestones and wasteload allocation tables.

Pat Boldt indicated that WRCAC would like to be excluded from the support letter if they are unable to review responses from Regional Board on their comments submitted. Lauren Briggs mentioned that the response to the comments document will be available at least 10 days before the Board hearing.

Minor Source Study Process

Tess proposed a process for the Minor Source Study, including convening a small group in early May to address criteria for identifying minor sources and their responsibilities within the TMDL context. The group will meet virtually from May through September, with consultants preparing a draft document for task force review in November. Anne Marie from Banning expresses interest in participating, but Tess notes that non-paying members' involvement requires further discussion regarding financial participation.

Update: LEAMS Future Options Study (Steve Wolosoff, GEI)

Steve Wolosoff from GEI provided a brief verbal update on the LEAMS Future Options Study, noting that the full draft report—spanning over 500 pages—was submitted to the TMDL Task Force around April 14–15, with comments requested by May 15. For accessibility, the report includes an executive summary that highlights the major findings, scientific and engineering analysis, scoring, costs, and recommendations. Supporting appendices cover sediment nutrient release and oxygen demand, hydrodynamic modeling led by Dr. Michael Anderson, detailed cost breakdowns, and an assessment of the existing LEAMS system, which was found to be serviceable in the short term but needing updates. Sudhir Mohleji from EVMWD emphasized that the report's conclusions and the ranking of alternatives remain unchanged from prior presentations—specifically, that oxygenation remains the recommended alternative. Once comments are received, GEI aims to quickly proceed to the next design and construction phases. The item will remain on the agenda for one more meeting to allow for a final wrap-up and possible public posting of the report.

Update: Lake Elsinore Water Quality Plan (Adam Gufarotti, City of Lake Elsinore) No discussion.

Update: Canvon Lake (LESJWA Staff)

Rick Whetsel provided an update on the recent alum application at Canyon Lake, which took place during the week of April 24–28, 2024. During this period, a sudden temperature increase likely triggered an algal bloom mid-application, particularly affecting the shallow, warmer East Bay where floating alum floc persisted. While the application was generally considered successful, the presence of floating floc raised concerns, and a follow-up review with consultants and stakeholders is planned to evaluate the process, timing, and potential improvements. Additionally, the team is working on amending the CEQA documentation before its expiration in December 2025 to maintain alum as a viable treatment option. Whetsel also reported a fish kill incident this past weekend about a month after the application, though he emphasized that alum typically binds quickly and is not expected to have lingered in the water column. LESJWA is collaborating with EVMWD staff and consultants to investigate possible causes, including lake stratification, sulfides, ammonia, or a potential golden algae bloom.

Chris Stransky, GEI, confirmed the team is conducting further analysis, including examining fish gills under a microscope and checking for ammonia levels, which can be more toxic at higher pH levels. Early indicators from recent monitoring show dissolved oxygen levels were acceptable at the surface, although stratification had occurred. The exact number and species of affected fish remain unclear, though initial photos suggest mostly bass, while previous events involved threadfin shad. Terri Reeder of the Santa Ana Regional Water Quality Control Board suggested improving documentation of such events through better public communication to support future investigations and avoid assumptions about alum's role. Whetsel acknowledged the need for a thorough review of alum application timing, as recent years of wetter weather have increased nutrient loads, complicating scheduling. Despite these challenges, he reaffirmed alum's long track record of success in reducing phosphorus levels in Canyon Lake.

Task Force Administration (LESJWA Staff)

Rick Whetsel presented the following items for the Task Force to consider:

A. Approve draft amendment #4 to extend the LE&CL TMDL Task Force

Rick Whetsel presented a draft amendment #4 to extend the LE&CL TMDL Task Force Agreement, for consideration by the Task Force through an administrative action.

A motion was put forward by Lynn Merrill representing the City of San Jacinto and second by Cynthia Gabaldon representing the Cities of Menifee, Perris, San Jacinto, and March JPA to approve.

MOVED, to approve Amendment #4 to extend the LE&CL TMDL Task Force Agreement for a period of two years to June 30, 2027.

B. Approve second year option to extend Aquatechnex Agreement for Services for Canyon Lake Alum Dosing.

Rick Whetsel stated that in February 2022 the Task Force approved a three-year agreement for services with Aquatechnex to conduct up to two (2) semi-annual Canyon Lake alum dosing. This agreement included two 1-year options to extend the agreement (four additional application events).

A motion was put forward by Lynn Merrill representing the City of San Jacinto and second by Anthony Budicin representing the Eastern Municipal Water District to approve.

MOVED, to direct LESJWA staff to exercise the second 1-year option to extend the Agreement for Services with Aquatechnex to provide semi-annual Canyon Lake alum dosing to support the Lake Elsinore and Canyon Lake TMDL Task force for CY 2026.

Other Business

No other business to discuss.
