### Call to Order/Introductions

The Basin Monitoring Program Task Force meeting was called to order at 2:02 p.m. by Ian Achimore with participants participating remotely. Brief introductions were made.

### Approval of March 2025 Meeting Notes

The March 24, 2025 meeting notes were approved as posted.

### Schedule of the Task Force's Long-Term Deliverables – Ian Achimore, SAWPA

Ian Achimore of SAWPA presented an updated schedule of the Task Force's long-term deliverables, highlighting key efforts through 2030. The schedule includes the Annual Report of Santa Ana River Water Quality led by Rick Whetsel, the ongoing special study of Total Dissolved Solids (TDS) in Santa Ana River Reach 3 with consultant WSC, and the Basin Plan Amendment focused on clarifying certain contents in Chapters 4 and 5. Tess Dunham of KSC, noted a proposed State budget trailer bill that could exempt certain Basin Plan amendments from California Environmental Quality Act if water quality objectives are not made less stringent.

Mr. Achimore also referenced the 2023 Data Gap Framework, reminding agencies in "high-priority" Groundwater Management Zones (GMZs) of the December 31, 2025 deadline to follow required next steps per the Framework. Other upcoming work includes the 2026 ambient water quality recomputation and related groundwater data updates, which will begin with a scoping and procurement process in mid-2025. Additionally, data gathering for the 2030 Integrated Report will start in 2027, which is related to the Reach 3 Special Study.

### Special Study of TDS for Santa Ana River Reach 3 – Joe Kingsbury, WSC

Joe Kingsbury from WSC provided the first status update on the Reach 3 TDS Special Study, following the April 10th project kickoff. WSC was awarded the contract through a competitive procurement process. The study aims to understand fluctuating TDS concentrations during baseflow conditions at the downstream end

of Reach 3. Mr. Kingsbury outlined the current focus on Task 1, which includes reviewing documents and compiling data from 2017–2024, mainly from Annual Reports of Santa Ana River Water Quality. Time series plots are being generated to help identify data trends and outliers. Task 2 - which involves outreach to local agencies to understand the planned groundwater monitoring efforts in the Reach 3 area and assess how these efforts can support the purpose of identifying TDS data gaps - will begin once more background data is compiled. Mr. Achimore reminded the group that this study will result in a collaboratively developed monitoring plan, with continued input from the Task Force.

**Potential Data Gaps Framework Reminder – Ian Achimore, SAWPA**

Mr. Achimore reminded the Task Force about the 2023 Data Gap Framework adopted by the group, specifically noting that high-priority GMZs, with at least one potential data gap, must take action by the December 31, 2025 deadline. These actions are the responsibility of the designated agencies, not SAWPA or the full Task Force. Ian will re-send the original September email, which includes links to the framework, a key table showing agency responsibilities, and steps to follow. SAWPA will follow up directly with these high-priority GMZs to check on progress.
