		Phase II TMDL Implementation Task 4 requires the Task Force to review and re-authorize existing in-lake Project(s) for Canyon Lake, and/or approve new in-Lake Project(s) within one year of the adoption of the revisions to the LE&CL TMDLs.
		Due to a number of factors related to the current Canyon Lake alum application program, it is recommended that the Task Force begin work now to prepare a Task 4 Work Plan to identify and describe key tasks to evaluate the effectiveness, and offsets provided by the existing alum project, and the feasibility of other in-lake projects to manage nutrients. Additionally, it is recommended that the Task force implement short term tasks identified to support the continued implementation of the existing alum program
		Recommendation: Direct LESJWA staff to prepare a Task Order for GEI Consultants.
5 min	8.	Task Force Administration (LESJWA Staff)
		Action Item: LEAMS 2024 TN Offset Credits Funding Allocation
		The 2024 Lake Elsinore Offset Report, which reports on the number TP and TN offset credits creater from the operations of LEAMS, revealed that there were no total nitrogen credits available to license to stakeholders for 2024.
		Due to the lack of available total nitrogen credits for 2024, LESJWA staff revised the LEAMS nutrient offset credit allocations to be based solely on the need for total phosphorus offset credits. A excess funds resulting from the reallocation of the 2024 nutrient offset credit allocations are being held in the Task Force reserve account.
		Recommendation: Direct LESJWA staff to apply excess funds being held in the Task Force reserve account to reduce stakeholder contributions for FY 2025-26 for stakeholders who purchased 2024 LEAMS nutrient offset credits.
