The Regular Meeting of the Santa Ana Watershed Project Authority Commission was called to order at 9:30 a.m. by Chair Gardner on behalf of the Santa Ana Watershed Project Authority, 11615 Sterling Avenue, Riverside, California, and Denis Bilodeau at 1960 Harbor Island Drive, San Diego, CA 92101.

6. NEW BUSINESS

A. PHASE 1 ELECTRIC VEHICLE CHARGER PROJECT AWARD (CM#2025.87)

Daniel Vasquez provided a presentation titled Phase 1 Electric Vehicle Charger Project Award, contained in the agenda packet on pages 23-33.

Mr. Vasquez provided a brief overview of Executive Order N-79-20, which drives CARB's Advanced Clean Fleet Regulation. The order directed that by 2026, 35% of new passenger cars and light trucks sold in California be zero-emission. Although private enforcement has been temporarily stayed, local governments are still required to comply, and SAWPA will be required to ensure that all new fleet purchases are zero-emission electric vehicles.

For Phase 1 of the electric vehicle charger project, the Commission directed staff to issue a Request for Proposal (RFP) in September. The RFP requested the purchase and installation of two dual-port chargers, allowing up to four (4) vehicles to charge simultaneously. Proposals were due November 6, 2025. All proposals received were evaluated based on qualifications, staffing and project organization, work plan, cost, and completeness. InCharge Energy received the highest overall score and is recommended for award at \$101,731.48.

Mr. Vasquz noted that the project tasks include a pre-construction phase with permitting, design approval, and site preparation; installation of pedestal-mounted chargers, trenching, system integration, and control setup; and testing and commissioning.

The schedule is to file the Notice of Exemption and approve the contract today. Permitting and procurement would begin immediately this month but acquire the equipment and obtain approvals from Riverside Public Utilities and the City of Riverside will take some time. As a result, it is anticipated that construction will begin in March 2026.

The recommendation is to direct the General Manager to file a Notice of Exemption for the Phase 1 EV Charger Project with the Riverside County Clerk's Office; and to execute a General Service Agreement and Task Order with InCharge Energy for an amount not to exceed \$101,731.48 for Phase 1 of the EV Charger Project. There was no discussion.

B. PROPOSITION 4 OVERVIEW (CM#2025.88)

lan Achimore provided a presentation titled Proposition 4 Overview, contained in the agenda packet on pages 171-180.

n July 2024, the legislature approved a \$10 billion bond (SB 867). The bond's focus includes safe drinking water, wildfire prevention, drought preparedness, and clean air, all aimed at improving the state's climate resilience. The bond passed with 60% of the vote, surpassing the 50% requirement.

A significant portion of the funding is earmarked for grants to water agencies, tribes, and non-governmental organizations. Like previous climate and water-related bonds, Proposition 4 allocates funding for Integrated Regional Water Management (IRWM), a priority for SAWPA and the OWOW Steering Committee. While earlier bonds allocated around \$500 million for IRWM, Proposition 4 only includes \$100 million, with a stronger focus on climate resilience. The decline in IRWM funding reflects the state's evolving approach to water and climate projects.

Mr. Achimore noted that the bond stipulates that at least 40% of the funds must benefit vulnerable populations, including disadvantaged communities. Funds must prioritize projects that leverage additional outside funding, and while there is no overall cost-share requirement, certain categories, like water recycling, may include one.

IRWM funding, a key focus for our region, will target climate resilience, and while the focus on disadvantaged communities remains, "vulnerable populations" is a new term that will require data-driven descriptions from applicants.

The bond allocates funding to several areas, with Chapter 2 focusing on water-related projects, including:

- \$15 million for stream gauges
- \$62 million for brackish desalination
- \$100 million for IRWM (with a climate resilience focus)
- \$385 million for water reuse and recycling
- \$585 million for water quality and safe drinking water

Other areas include funding for wildfire and forest resilience, coastal resilience, extreme heat mitigation, nature-based solutions, climate-smart agriculture, and clean air and energy.

Mr. Achimore noted that the Department of Water Resources is leading this effort, and state agencies are in the process of developing guidelines for the funds. SAWPA is tracking the bond and will provide periodic updates to the OWOW Steering Committee and SAWPA Commission, especially as it relates to the \$100 Million in IRWM funding.

Commissioner Botello inquired about the "vulnerable populations" clause and the focus on climate resilience for the IRWM funds, our service area, and every agency in this JPA has vulnerable populations in at-risk environments. It would be beneficial, especially OWOW, to really unpack the definition of "vulnerable populations" and develop some guidelines for how to address this focus.

Additionally, Commissioner Botello suggests when preparing the CARP report, it should incorporate this "vulnerable populations" definition. We will need to understand what this really means in practice to align with the criteria. It was also interesting to note that during the OWOW presentation, the members were very perceptive and some of the questions raised were about the timeline, specifically, concerns that we might not have access to the grant funding until 2027. Is that timeline realistic?

Mr. Achimore noted that the guidelines for the Proposition 4 funding need to be drafted, followed by a draft release, a comment period, and finalization. As a result, applications will not be available until 2027. However, the CARP is currently being developed, which aligns well with the timeline for the funding. As work on the CARP progresses, projects will emerge in conceptual form and later become more shovel-ready, which should fit the funding process once the guidelines are finalized.

Chair Gardner noted that SAWPA and the member agencies will want to be involved in the development of the regulations. There may be an opportunity to share feedback with staff before the draft regulations are released. The goal is to provide input on the draft regulations, with the hope of shaping them in a way that makes the funding more beneficial to our region.
